# RESOLUTION TO IMPLEMENT TELECONFERENCING REQUIREMENTS DURING A PROCLAIMED STATE OF EMERGENCY

**WHEREAS**, the Ralph M. Brown Act requires that all meetings of a legislative body of a local agency be open and public and that any person may attend and participate in such meetings; and

**WHEREAS**, the Brown Act allows for legislative bodies to hold meetings by teleconference, but imposes specific requirements for doing so; and

**WHEREAS**, on March 17, 2020, in order to address the need for public meetings during the present public health emergency, Governor Newsom issued Executive Order No. N-29-20, suspending the Act's teleconferencing requirements; and

**WHEREAS**, on June 11, 2021, Governor Newsom issued Executive Order No. N-8-21, continuing the suspension of the Brown Act's teleconferencing requirements through September 30, 2021; and

**WHEREAS**, these Executive Orders allowed legislative bodies to meet virtually as long as certain notice and accessibility requirements were met; and

**WHEREAS**, the State Legislature amended the Brown Act through Assembly Bill No. 361 (AB 361) on September 16, 2021; and

**WHEREAS,** AB 361 amended the Brown Act so that a local agency may use teleconferencing without complying with the regular teleconferencing requirements of the Act, where the legislative body holds a meeting during a proclaimed state of emergency and makes certain findings; and

**WHEREAS,** Government Code section 54953 requires that the legislative body make additional findings every 30 days in order to continue such teleconferencing.

**NOW THEREFORE**, the Board of Directors of the South San Joaquin Groundwater Sustainability Agency hereby finds, determines, declares, orders, and resolves as follows:

- 1. That the foregoing recitals are true and correct and incorporates them by this reference.
- 2. The Board of Directors of the South San Joaquin Groundwater Sustainability Agency finds, by a majority vote, the following:
  - a. That there exists a proclaimed state of emergency; and
  - b. State or local officials have imposed or recommended measures to promote social distancing.
- 3. District staff is authorized to take all steps and perform all actions necessary to execute and implement this Resolution in compliance with Government Code section 54953.
- 4. That this Resolution shall take effect **July 21, 2022** and shall remain in effect for thirty (30) days thereafter (until August 20, 2022), provided the conditions set forth in Section 2 remain.
- 5. This Resolution repeals and replaces Resolution 22-05-Y.

# Item #2 – Public Hearing Regarding Adoption of the Revised Eastern San Joaquin Groundwater Subbasin Groundwater Sustainability Plan

Mr. Brandon Nakagawa, SSJGSA Secretary and SSJID Water Resources Coordinator, addressed the Board and gave a PowerPoint presentation depicting status of the Eastern San Joaquin Groundwater Authority's (ESJGWA) Eastern San Joaquin Groundwater Subbasin Groundwater Sustainability Plan (GSP) of which the SSJGSA is a member agency; response and approach to the California Department of Water Resources' (DWR) comments of the initial GSP submitted in January 2019; and corrective actions. He provided detailed explanations of DWR's requirements to address all deficiencies identified in the initial GSP through preparation and submittal of a "Technical Memorandum" (TM); DWR's identified deficiencies including water year designations, water availability for recharge analysis, adaptive management options, shallow wells, drinking water impacts, groundwater quality, and subsidence; corrective actions listed in TM 1, 2, 3 and 4; hydrologic groundwater budget comparisons; groundwater projects; and minimum thresholds.

Mr. Nakagawa summarized that all ESJGWA GSAs are set to adopt the revised GSP by their respective boards and councils allowing the ESJGWA to submit the revised plan to DWR by the July 27 deadline, and if all member GSAs fail to adopt the revised GSP, DWR and the State Water Resources Control Board (SWRCB) will initiate state intervention. He added that it is speculated that state intervention would occur only to the individual member GSAs who have not adopted the revised GSP, and not the entire ESJGWA.

Staff recommended the Board open the Public Hearing to receive testimony from the public regarding revisions to the GSP, and adopt Resolution 22-07-W Adopting the Revised Eastern San Joaquin Groundwater Subbasin Groundwater Sustainability Plan.

Board discussion included commending Mr. Nakagawa on the concise update; accounting hours and/or budget amounts required to revise and further implement the GSP; and lack of legislation declaring a response time for DWR to respond to the revised GSP. Mr. Nakagawa stated that once the ESJGWA GSP is submitted and posted on the DWR website, it will initiate a 60-day public comment period and that public comments are anticipated from environmental groups.

## RESOLUTION ADOPTING THE REVISED EASTERN SAN JOAQUIN GROUNDWATER SUBBASIN GROUNDWATER SUSTAINABILITY PLAN

**WHEREAS,** on August 29, 2014, the California Legislature passed, and on September 16, 2014, the Governor signed legislation creating the Sustainable Groundwater Management Act ("SGMA") "to provide local groundwater sustainability agencies with the authority and technical and financial assistance necessary to sustainably manage groundwater" (Wat. Code, § 10720, (d)); and

**WHEREAS**, SGMA requires sustainable management through the development of groundwater sustainability plans ("GSPs"), which can be a single plan developed by one or more groundwater sustainability agencies ("GSA") or multiple coordinate plans within a basin or subbasin (Wat. Code, § 10727); and

**WHEREAS**, Division 13 commencing with Section 21000 of the Public Resources Code (California Environmental Quality Act) does not apply to the preparation and adoption of GSPs (Wat. Code, § 10728.6); and

**WHEREAS**, SGMA requires a GSA to manage groundwater in all basins designated by the Department of Water Resources ("DWR") as a medium or high priority, including the Eastern San Joaquin Subbasin (designated basin number 5-22.01); and

**WHEREAS**, the City of Escalon, City of Ripon, and the South San Joaquin Irrigation District (SSJID) have jointly and collectively formed South San Joaquin County Groundwater Sustainability Agency (SSJGSA) as a Joint Powers Authority pursuant to Government Code § 6500 *et seq.*, which is a public entity separate and apart from its members; and

WHEREAS, SSJGSA has the authority to draft, adopt, and implement a GSP (Wat. Code, § 10725 *et seq.*); and

**WHEREAS**, the SSJGSA is a member of the Eastern San Joaquin Groundwater Authority ("ESJGWA") formed as a Joint Powers Authority pursuant to Government Code § 6500 *et seq.* for the purpose developing a single GSP and coordinating sustainable groundwater management in the Eastern San Joaquin Subbasin (Wat. Code, § 10723.6<sup>•</sup>); and

**WHEREAS**, the ESJGWA submitted an Initial Notification to DWR on behalf of its members to jointly develop a single GSP for the Eastern San Joaquin Subbasin on February 8, 2017; and

**WHEREAS**, the SSJGSA has coordinated and continues to coordinate with all other GSAs in the Eastern San Joaquin Subbasin through the ESJGWA; and

**WHEREAS,** on November 20, 2019, the SSJGSA Board of Directors held a public hearing to consider public comment and prior to adopting the ESJ GSP; and

**WHEREAS**, the ESJ GSP was submitted to the DWR and posted on DWR's SGMA portal on January 19, 2019, initiating the statutory public comment period and review by DWR; and

**WHEREAS,** on January 28, 2022, the DWR issued a letter to the ESJGWA indicating that the submitted ESJ GSP was determined to be incomplete and directing the ESJGWA to address all identified deficiencies by July 27, 2022; and

**WHEREAS,** the ESJGWA has prepared significant revisions to the ESJ GSP supported by additional technical analysis and policy discussions which have been memorialized in several technical memoranda; and

**WHEREAS**, the ESJGWA has made the Revised ESJ GSP and supporting documents available to the public at <u>www.ESJGroundwater.org</u>; and

**WHEREAS,** on April 15, 2022, the ESJGWA published a Notice of Intent to Adopt an Amended Groundwater Sustainability Plan pursuant to Water Code Section 10728.4; and

**WHEREAS,** on July 5 and 12, 2022, the SSJGSA published in the Manteca Bulletin a Notice of Public Hearing pursuant to Government Code Section 6066 setting the public hearing and adoption date of the Revised ESJ GSP at 9:00 a.m., Wednesday, July 20, 2022, in the South San Joaquin Irrigation District Board Room in Manteca, California; and

**WHEREAS,** on July 20, 2022, the SSJGSA Board of Directors held a public hearing to consider public comments prior to adopting the Revised ESJ GSP.

**NOW, THEREFORE, BE IT RESOLVED** that the Board of Directors of the SSJGSA hereby approves as follows:

- 1. The SSJGSA Board of Directors adopts the Revised ESJ GSP attached hereto as Exhibit A.
- 2. The SSJGSA hereby authorizes the ESJGWA, its consultants, and the Plan Manager to take such other actions as may be reasonably necessary to submit the Revised ESJ GSP and all other required documentation to DWR by July 27, 2022.

## Item #7 – Quarterly Presentation of YTD Financials through June 2022

Ms. Bloom addressed the Board and stated she had SSJGSA checks requiring signature from the Chairman or Vice-chair. The checks were handed to Vice-chair de Graaf for signature.

Ms. Bloom distributed a handout titled South San Joaquin Groundwater Sustainability Agency Financial Statements June 30, 2022. She provided detailed descriptions of the balance sheets, bank reconciliation, statement of changes in net position, statements of members' capital, budget comparison of actual expenses and remaining budget; and total expenses incurred through June 2022 including additional charges from SSJID to the SSJGSA, and the Groundwater Resources Association. She noted that total 2022 SSJGSA expenses incurred by SSJID of \$51,907.00 versus the SSJGSA reimbursements to SSJID of \$49,422.00 show a difference of \$2,485.00 due to a late adjustment to be settled in future billing, which occurred due to under billing the member agencies in the April-June quarter.

Board discussion included that the term of the SSJGSA budget is annually from January through December; the auditors (Brown Armstrong) are still working on the SSJID annual audit and the SSJGSA audit; and the ESJGWA invoice for SSJGSA dues for fiscal year (FY) 2022-23, in the amount of \$21,000.00, is expected in August.

## Item #8 – Discussion and Possible Action on Eastern San Joaquin Groundwater Authority Business

Mr. Nakagawa reported that the ESJGWA budget was approved for FY 2022-23 and that the ESJGSA membership dues will remain the same as the previous year(s).

Mr. Nakagawa reiterated that all sixteen (16) member GSAs in the ESJGWA are set to adopt the revised GSP by their respective boards and councils, and the ESJGWA will submit the revised GSP to DWR by the July 27 deadline. Once the revised GSP has been fully adopted, the next steps will be for the ESJGWA to begin the accounting framework, to prioritize SGMA projects and investment amounts, and to identify groundwater recharge credit recipients (e.g. landowner, GSA, and/or ESJGWA).

Board discussion included that the ESJGWA continue to move forward in a positive direction; preparation by the ESJGWA of DWR's responses to the revised GSP which will be provided via DWR's portal; and subsequent coordinated responses, if any, from the ESJGWA GSAs.

Mr. Nakagawa reported that, to date, two required (2) GSA Verification Statements and Well Drilling Permit Acknowledgement Forms were submitted to the San Joaquin County (SJC) Environmental Health Department (EHD) regarding proposed well applications in the SSJGSA region.

Mr. Nakagawa announced the San Joaquin Farm Bureau Water Advisory Committee meeting on July 26, at 5:30 p.m. Mr. Steve Shih, SJC EHD, is slated as a guest speaker to discuss the County's well permitting process.
