COMMUNICATIONS

Item #1 – Directors' Reports

Director Roos attended the San Joaquin Farm Bureau (SJFB) Calla Nile and Escalon Farm Centers Dinner. He said that it was very informative and he enjoyed it very much.

Director Kamper stated that he had an article regarding labor unions to share with the Board.

Director Spyksma attended the San Joaquin Tributaries Authority (SJTA) meeting. They are working on a strategy to communicate with the public to let them know what they are about.

Director Holbrook reported on the following:

- Expressed concern for future facility plans for the District. He stated that the District is currently at maximum capacity, and if it were to undertake retail electric, permits for a new facility could take several years.
- Director Holbrook stated that while there is a push by the state to switch over to electric vehicles, the District should be purchasing diesel and gas vehicles according to the Shop Manager's recommendations.
- He would also like to make sure that staff is getting the equipment they need to perform the work according to the Water Master Plan. Forrest Killingsworth, Engineering Department Manager, explained that the pipe lining equipment has been purchased and that there is a learning curve to operate the equipment. He stated that District staff has learned a lot this season and will eventually become experts with the equipment.
- He read an article from NewsData Meter Readings regarding certain groups wanting to take away senior water rights of water districts.

President Weststeyn stated that he attended the SJFB Farm Center's Dinner and Water Advisory Meeting.

Item #2 – Various Reports

Mr. Peter Rietkerk, General Manager, attended the SJFB Farm Center's Dinner and spoke about rate increases and the District's current Prop 218 process. He said it was well received by the audience and they expressed understanding regarding the District's long-term capital improvement program to promote reliability and improved service.

Mr. Rietkerk stated that he would like to meet with Director Holbrook regarding the items he expressed concerns for, and provide an update at a future board meeting on several of the topics addressed in his comments.

ACTION CALENDAR

Item #3 – Consider Adoption of Resolution 23-08-C Approving the Initial Study/Mitigated Negative Declaration for the Canyon Tunnel Project

Mr. Killingsworth addressed the Board and explained that the Initial Study/Mitigated Negative Declaration for the Canyon Tunnel Project is prepared to study any impacts the project would have on the environment and to identify steps to mitigate those impacts.

The study was posted and distributed for review and public comments from January 25 – February 23, 2023. During that time, four comment letters were received. Letters were received from Stanislaus County regarding the traffic impacts to Knights Ferry and from the San Joaquin Valley Air Pollution Control District regarding the requirement to submit an Air Impact Assessment application. Staff has provided written responses regarding all comments received.

President Weststeyn and Director Spyksma suggested that information be given to the Knights Ferry community ahead of time, and that measures be taken to ensure that the roads are maintained and cleaned of any dirt, rocks, etc. Mr. Killingsworth explained that the California Environmental Quality Act (CEQA) process is separate from the construction plan, and although those are not addressed in this document, they will be addressed in the construction documents. Additional discussion included strategies for a public outreach plan, proactive engagement with both the Stanislaus County Transportation Department and the Knights Ferry Municipal Advisory Council, and the Board's interest in responsibly executing the Canyon Tunnel Project.

MOTION: A motion was made by Director Holbrook and seconded by Director Roos to Adopt Resolution No. 23-08-C adopting the Initial Study/Mitigated Negative Declaration and Mitigation Monitoring and Reporting Program for the Canyon Tunnel Project; Authorize the Engineering Department Manager to file the three necessary Notice of Determinations with the Calaveras, Stanislaus and Tuolumne County Clerk Offices and the State Office of Planning and Research; and authorize issuance of a check to Stanislaus County for the 2023 California Department of Fish and Wildlife (CDFW) CEQA Fee in the amount of \$2,821.00.

SOUTH SAN JOAQUIN IRRIGATION DISTRICT RESOLUTION NO. 23-08-C

ADOPTION OF A MITIGATED NEGATIVE DECLARATION AND MITIGATION MONITORING AND REPORTING PROGRAM FOR THE CANYON TUNNEL PROJECT

WHEREAS, South San Joaquin Irrigation District (SSJID) prepared an Initial Study/Mitigated Negative Declaration (IS/MND) for the proposed Canyon Tunnel Project (Project) in accordance with requirements of the California Environmental Quality Act (CEQA) and the CEQA Guidelines; and

WHEREAS, the Project is for the construction of the Canyon Tunnel. The Project consists of a new water conveyance tunnel (approximately 12,000 lineal feet, 1,000 feet hard rock and 11,000 feet soft rock) to bypass approximately 12,250 lineal feet of existing canal, referred to as the Joint Supply Canal (JSC); and

WHEREAS, on January 24, 2023, SSJID filed a Notice of Intent to adopt an IS/MND with the Calaveras County Clerk, Tuolumne County Clerk, and Stanislaus County Clerk and said Notice of Intent advertised a 30-day review and comment period starting on January 25, 2023, and ending on February 23, 2023; and

WHEREAS, said Notice of Intent indicated that SSJID intends to consider said IS/MND at a regular meeting on March 14, 2023; and

WHEREAS, four (4) comment letters were received, from Stanislaus County Department of Environmental Resources, Central Valley Regional Water Quality Control Board; Stanislaus County Environmental Review Committee; and San Joaquin Valley Air Pollution Control District; and

- On February 8, 2023, comments were received from Stanislaus County Department of Environmental Resources; and
- On February 22, 2023, comments were received from Central Valley Regional Water Quality Control Board; and
- On March 1, 2023, comments were received from Stanislaus County Environmental Review Committee; and
- On March 6, 2023, comments were received from San Joaquin Valley Air Pollution Control District; and

WHEREAS, the comment letters received do not necessitate recirculation of the IS/MND pursuant to CEQA Guidelines Section 15073.5; and

WHEREAS, the District finds that it cannot be fairly argued, nor is there any substantial evidence in the record, that the project could have a significant effect on the environment, either directly or indirectly; and

WHEREAS, based upon the IS/MND and the record, the project will not individually or cumulatively

have an adverse impact on environmental resources; and

WHEREAS, the Board believes the approval of the IS/MND will be in the best interest of the District's landowners and water users; and

WHEREAS, the District is the custodian of the documents and other materials that constitute the record of proceedings upon which the District's decision is based, and 11011 E. Highway 120, Manteca, CA 95336 is the location of this record.

NOW, THEREFORE, BE IT RESOLVED, by the Board of Directors of the South San Joaquin Irrigation District that:

- 1. The South San Joaquin Irrigation District Board of Directors adopts the IS/MND including the MMRP for the Canyon Tunnel Project.
- 2. The Engineering Department Manager of the South San Joaquin Irrigation District is hereby authorized and directed to prepare the three (3) Notice of Determinations to be filed with the Calaveras, Stanislaus, and Tuolumne County Clerk Offices and the State Office of Planning and Research.

Item #6 – Consider Budget Amendment Supporting San Joaquin Tributary Authority Membership Dues for 2023

Item #7 – Consider Opposition of Initiative No. 21-0042, "The Taxpayer Protection and Government Accountability Act," and Adoption of Resolution No. 23-08-O Opposing Legislative Initiative No. 21-0042

Ms. Patterson addressed the Board and explained that The Taxpayer Protection and Government Accountability Act includes provisions that would retroactively void all state and local taxes or fees adopted after January 1, 2022, if they do not align with the provisions of this initiative. This may also affect indexed fees that adjust over time for inflation. She stated that this would allow voters throughout California to invalidate the prior actions of local voters, undermining local control and voter-approved decisions about investments needed in their

communities. Should this initiative pass, future adopted rates by the District would be subject to the initiative's language which would be detrimental to SSJID being able to raise revenues to keep up with the rising costs of services.

WHEREAS, the measure creates new constitutional loopholes that would allow corporations to pay less than their fair share for the impacts they impose on our communities, including local infrastructure, our environment, water quality, air quality, and natural resources; and

WHEREAS, the measure threatens billions of dollars currently dedicated to state and local services, and could force cuts to irrigation and drinking water services by South San Joaquin Irrigation District for its customers and its communities, as well as public schools, fire and emergency response, law enforcement, public health, parks, libraries, affordable housing, services to address homelessness, mental health services, and more; and

WHEREAS, the measure would also reduce funding for critical infrastructure like streets and roads, public transportation, ports, drinking water, irrigation water, sanitation, utilities, and more.

NOW THEREFORE, BE IT RESOLVED that the South San Joaquin Irrigation District opposes Initiative 21-0042A1; and

BE IT FURTHER RESOLVED, that the South San Joaquin Irrigation District will join the "No on Initiative 21-0042A1" coalition, a growing coalition of public safety, labor, local government, infrastructure advocates, and other organizations throughout the state; and
