### READY TO RESPOND

**Another wet winter?** The impacts of heavy rainfall this past winter were felt throughout the year as we dealt with a late start to the irrigation season, reduced irrigation demand, and unanticipated maintenance to repair storm damage. With this past water year and irrigation season now in the books, we start looking ahead toward this upcoming winter outlook. So far, its' shaping up to be another wet year, with a very strong El Niño pattern forecasted, which could result in warmer and wetter conditions—just how wet remains to be seen. We welcome the strengthening of our local water supplies, but wet weather can create challenges during both irrigation and maintenance periods. Thankfully, after several years of drought, we learned a lot this past rainy season and we are well prepared going into winter.

SSJID cares about how water legislation impacts our region. During the legislative session, SSJID acted to protect our pre-1914 appropriative water rights, which are vital to the region's agricultural economy and support community growth, housing and development goals. SSJID worked through local and statewide coalitions to stall two bills, Assembly Bill (AB) 460 and AB 1337, and get clarifying language on Senate Bill 389. At the end of the day, SSJID will always continue to safeguard our water rights for customers and bring value to our local communities.

SSJID protects water reliability in many ways, including through our Water Master Plan (WMP). The plan was approved by the Board of Directors in December 2022 and outlines improvement projects that will bolster and maintain SSJID's operations into the future. Following the approval of the WMP, SSJID proposed a rate change this year that would allow SSJID to continue to provide an affordable, dependable water supply with outstanding service to our irrigation customers, all while maintaining fiscal responsibility.

## **Irrigation Season Ends**

Irrigation season ended on October 29. As we enter maintenance season this November, remember to contact SSJID about any projects happening on your own property that may affect the District's irrigation system, including new irrigation systems and structures. This was a direct result of the WMP efforts which concluded irrigation rate increases would be necessary to:



Afford ongoing operations and maintenance



**Conduct timely infrastructure** repair, rehabilitation, and replacement



Accelerate an aggressive capital improvement



Maintain financial stability

The rate increase was approved by the Board of Directors in July of 2023, and we are already making headway on projects, including new processes such as spray cast pipelining. SSJID anticipates completing 10,000 linear feet of pipelining across the District in the 2023-2024 maintenance season. Also part of the WMP, the Canyon Tunnel Project will create a twomile-long Joint Supply Canal Bypass Tunnel originating from Goodwin Dam down to the vehicular bridge/access ramp. The project is currently 90 percent designed and is expected to break ground in mid-2025.

We're looking for opportunities to support projects that enhance our services and infrastructure. SSJID was part of a group of local water agencies that received \$5 million from the California Department of Food and Agriculture, State Water Efficiency and Enhancement Program (SWEEP), of which SSJID's share is \$500,000. The grant will fund projects that improve on-farm irrigation efficiency and reduce water use and greenhouse gas emissions. 

## MAINTENANCE UPDATES:

A FUTURISTIC VIEW

SSJID completed a variety of projects to keep water flowing smoothly during this year's irrigation season. One of the most notable tasks was the installation of 2,000 feet of high density poly-ethylene (HDPE) liner on the Frankenheimer Power Canal to fix an existing, aging concrete liner. The District collaborated with Turlock Irrigation District (TID), who operates SSJID's Frankenheimer hydroelectric unit, to complete this work. The HDPE liner has a life expectancy of 20 years, extending the usefulness of the canal well into the future.

As we head into the 2023-2024 maintenance season, SSJID plans to complete numerous projects that will support upcoming irrigation seasons. We anticipate:



Completing 10,000 linear feet of pipelining across the District.




Automating gates and sensors at laterals Kac and R364dd.



Maintaining the Upper Main Supply Canal with planned shotcrete and gunite repairs for 3,500 linear feet.



Tackling several control box and float valve construction projects. These include two single cell boxes on laterals Haa and OB, a pour over box on the Wc, a float valve two-way connection on the H93dd, and cutting down pour over walls where necessary.



The project is a crucial piece of maintenance to our delivery system. The tunnel is part of the Joint Supply Canal at Goodwin Dam, which carries water by gravity from the Stanislaus River – through hills and mountains – to our service area. SSJID General Manager Peter Rietkerk said, "These facilities are important for us to maintain so that we can keep water flowing to the region, and they require maintenance and construction in varying degrees annually to assure their integrity."

SSJID is committed to maintaining our system components to ensure a dependable supply of water. Additional projects may be added or prioritized after end of season inspections. For more information, contact SSJID at (209) 249-4600.





## TOUR PROMOTES REGIONAL EDUCATION

# SSJID ADOPTS NEW RATES TO FUND RELIABLE IRRIGATION

The SSJID Board of Directors approved an irrigation rate increase on July 25, 2023. The rate increases will take effect in the following manner:

- ✓ The flat acreage rate will be collected on the 2023/2024 San Joaquin County Property Tax Bill
- √ The volumetric rate will be billed during the 2024 Irrigation Season

This does not change the way customers pay their irrigation bills. Customers will continue to pay the flat acreage rate on their property tax bills issued by San Joaquin County, and their volumetric bills via online payment or at the District's Office at 11011 E. Highway 120, Manteca, CA 95336.

The new water rates are included in the table below:

RATE CATEGORY	2024
Flat – per acre	\$38.00
Volumetric – Tier 1 (<= 48") – per acre-feet	\$5.00
Volumetric – Tier 2 (> 48") – per acre-feet	\$12.50
Minimum Charge – Flat Rate	\$50.00







**SSJID hired an independent financial expert** to prepare a detailed Cost-of-Service Analysis to show the full cost of providing irrigation service, including the amount of irrigation non-rate revenues and general-purpose revenues used to cover those costs.

### SSJID HOSTS ALMOND INDUSTRY LEADERS



In August, SSJID hosted the Almond Leadership Program (ALP), a group of 18 professionals immersed in the Almond Board of California's industry leadership course. The District engaged the ALP in a discussion of emerging water issues, offered a tour of the pressurized irrigation system, and showcased the adopted Capital Improvement Plan. SSJID also guided a session on how an irrigation district manages and distributes irrigation water in a complex regulatory environment, with resulting impacts on water management by farmers. Historical context provided framing for the discussion.

# CONTROL MOSQUITOES NOW TO "FIGHT THE BITE" NEXT SPRING

As winter approaches, mosquitoes will be far from our minds, but these annoying creatures are still planning their reemergence for next spring. Mosquitoes increase their populations late in the season to ensure their survival the following year. Female mosquitoes deposit their eggs in items that hold as little as a half-inch of water, while others lay them on damp ground or even glue them to the sides of containers. Some species will overwinter as adults, hiding under tarps, in sheds, and anywhere they can escape the frost and frigid winter winds. Mosquitoes can carry diseases, including West Nile virus, which can be deadly in humans. Here are some steps you can take to help prevent mosquitoes from returning around your home and farm:



- Inspect outdoor areas and drain water that may stand longer than 96 hours. Drill drainage holes, cover, invert, or eliminate any outdoor container or object holding standing water (saucers under potted plants, buckets, jars, trash cans, tarps, boats, etc.).
  - Install surface drains to remove excess water that collects at lower levels of irrigated fields.
- Back-fill tire ruts or other low areas that can hold water.
- Ensure drainage channels are vegetation and debrisfree with a proper grade to promote quick drainage.
- Clean clogged rain gutters and yard drains so they flow freely.
- Keep inlets free of accumulations of sediment, trash, and debris to prevent standing water from backing up on roadways and gutters.

- Inspect, maintain, and repair irrigation systems to avoid leaks and runoff into storm drains.
  - Use pumps or aerators to keep water moving in ponds and other ornamental water features.
  - Completely drain and refill water in birdbaths, unchlorinated fountains, and animal troughs regularly. Keep swimming pools chlorinated and pumps and filters operating. Unused or unwanted pools need to be emptied and dry or removed. Add mosquitoeating fish to larger water sources, including ornamental ponds, unmaintained "green" pools, water retention ponds, and water troughs.
    - Prevent mosquito breeding in rainwater catchment systems such as rain barrels by properly screening all openings.
