SOUTH SAN JOAQUIN IRRIGATION DISTRICT RESOLUTION 22-19-W

RESOLUTION APPROVING A WATER TRANSFER AGREEMENT BY AND BETWEEN SOUTH SAN JOAQUIN IRRIGATION DISTRICT AND MOUNTAIN HOUSE COMMUNITY SERVICES DISTRICT

WHEREAS, the South San Joaquin Irrigation District ("SSJID") is a California irrigation district operating under and by virtue of Division 11 of the California Water Code; and

WHEREAS, the Mountain House Community Services District is a California community services district governed by Division 3 of Title 6 of the California Government Code and a legal subdivision of the State of California; and

WHEREAS, the Mountain House Community Services District has declared a Stage 3 Water Shortage Emergency and has determined that due to ongoing and severe drought conditions, water supplies are projected to be inadequate to meet the community's health and safety needs; and

WHEREAS, SSJID is co-owner of certain water rights on the Stanislaus River, including pre-1914 and post-1914 appropriative rights; and

WHEREAS, SSJID's historic and ongoing use of Stanislaus River delivered through its conveyance, storage, and delivery facilities contributes significant recharge to the Eastern San Joaquin Subbasin and enables groundwater supplies within SSJID to remain healthy; and

WHEREAS, SSJID owns and operates a number of groundwater wells to supplement surface water supplies and to lower the groundwater table in areas of the District where the high groundwater table negatively impacts crop production; and

WHEREAS, the SSJID Board of Directors has determined that groundwater surplus to current District demands is available for transfer to Mountain House Community Services District; and

WHEREAS, the proposed transfer (Project) would utilize existing drainage, water conveyance and diversion infrastructure; and

WHEREAS, Mountain House will serve as the lead agency for purposes of compliance with the California Environmental Quality Act (CEQA).

NOW, THEREFORE, BE IT RESOLVED that the South San Joaquin Irrigation District Board of Directors does hereby approve a water transfer agreement with the Mountain House Community Services District and authorizes the General Manager to sign the agreement upon negotiation of final terms as directed by this Board of Directors.
