Item #1 – Directors and staff's report from APPA Conference

Director Holbrook said it was a great conference and the main theme is that solar is creating challenges for the utilities nationwide. Some communities have over 50% solar use and it is anticipated the electrical industry will not be the same in the next 3 to 4 years. The nation is cutting down on water power, going green, but we do not have the capacity. The drought is causing more problems with producing electricity. The other issue is security and there has been a 300 to 400 percent increase in cyber intrusions at water, sewer, and power plants throughout the nation. He also participated in the Day of Giving at a local shelter for abused women and children.

Mr. Don Battles, Utility Systems Director, confirmed that this APPA conference contrasted favorably with prior conferences. They talked much about renewable energy and integrating them into the grid. Cal-ISO will become a major grid supplier outside of California in the near future.

Mr. Jeff Shields, General Manager, spent a lot of time in the exhibit area visiting Moody's Financing to discuss retail electric and pressurized irrigation systems to find out more about the financial structure and how curtailment orders affect District ratings.

Mr. Steve Emrick, General Counsel, said many people think that California, Nevada, Florida, and Arizona are the solar states, but that is not the case. Solar is affecting many other states in the nation.

Mr. Bere Lindley, Finance and Administration Manager, reported he learned a lot regarding distributed generation and the impacts of solar panels on rooftops. He said that solar uses less kilowatt hours, generating less revenue for the utility companies. The utility can consider

increasing rates but they would be ridiculously high. He says the fixed rates must be adjusted. Solar power cannot be balanced but the load and generation must be balanced.
